
The Unit Approval Committee confirmed and ratified the minutes of the UAC meeting held on 25.04.2019.

**5.1 Request from M/s. Adam Quartz Fabrication & Exports Private Limited for setting up an 100% EOU:- :-**

The proposal of M/s. Adam Quartz Fabrication & Exports Private Limited for setting up their EOU at D-26, Ambattur Industrial Estate, Ambattur, Chennai-600 058 for manufacture and export of Stone Counter Tops(Quartz) made out of Cement Blocks with a projected investment of ₹ 136 lakh and projected NFEE of ₹ 1,903 lakh over a period of 5 years with an employment generation for 10 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Para 6(a) of Foreign Trade Policy and 6.01(b)(i) of Handbook of Procedures, 2015-2020.

**5.2 Request from M/s. Team Detailing Solutions Private Limited for setting up a new Unit :-**

The proposal of M/s. Team Detailing Solutions Private Limited, for setting up their Unit for IT/ITES (Engineering Services-2D/3D Design and Drawing - CPC Code 8672) at ETA Technopark SEZ, Navalur with a projected investment of ₹ 50 lakh and projected NFEE of ₹ 4,250 lakh over a period of 5 years with an employment generation for 50 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Rule 18(2) of SEZ Rules, 2006.



**5.3 Request from M/s. Wabco India Limited for setting up a new Unit :-**

The proposal of M/s. Wabco India Limited, for setting up their 3<sup>rd</sup> Unit in Mahindra World City SEZ for Auto Engineering for manufacture and export of Double Diaphragm Spring Brake Chamber, Compressor 160CC, Compressor DFCV, Light Duty Air Disc Brake Lever and Crank Shaft with a projected investment of ₹ 3,895 lakh and projected NFEE of ₹ 42,216 lakh over a period of 5 years with an employment generation for 210 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Rule 18(2) of SEZ Rules, 2006.

**5.4 Request from M/s. Statestreet HCL Services Private Limited for setting up a new Unit :-**


The proposal of M/s. Statestreet HCL Services Private Limited, for setting up their Unit for IT/ITES (Computer Software services including Information Enabled Services such as Back Office operations, Call Centres, Content development of animation, Data Processing, Engineering & Design - CPC 8672), Graphic Information System Services, Human Resources Services, Insurance Claim processing, Remote maintenance, Support Centres and web-site services and off-shore banking services) at Platinum Holdings SEZ, Navalur with a projected investment of ₹ 5,991 lakh and projected NFEE of ₹ 75,910 lakh over a period of 5 years with an employment generation for 2004 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Rule 18(2) of SEZ Rules, 2006.

**5.5 Request from M/s. Wirecard India Private Limited for setting up a new Unit :-**

The proposal of M/s. Wirecard India Private Limited, for setting up their Unit for IT/ITES at TRIL Info Park SEZ, Taramani, Chennai with a projected investment of ₹ 386 lakh and projected NFEE of ₹ 6,418 lakh over a period of 5 years with an employment generation for 80 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Rule 18(2) of SEZ Rules, 2006.

**5.6 Request from M/s. Flamax India Grooved Fittings Private Limited for conversion of their DTA Unit into an 100% EOU:- :-**

The proposal of M/s. Flamax India Grooved Fittings Private Limited for conversion of their DTA Unit at No.1/289, Pollachi Road, Opp:KMEPF India, Maumachampatty P.O. Coimbatore to EOU for manufacture and export of Grooved Pipe Fittings (ITC HS Code:73071120) with a projected investment of ₹ 110 lakh and projected NFEE of ₹ 597 lakh over a period of 5 years with an employment generation for 28 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Para 6.19(a) of Foreign Trade Policy and 6.01(b)(i) of Handbook of Procedures, 2015-2020.





**5.7 Request of M/s. Transunion Global Technology Center LLP for surrender of space:-**

The request for approval for surrendering of 19, 372 sqft of space in 10<sup>th</sup> Floor (part) In Block-2 In DLF-SEZ by M/s. **5.9 Request from M/s. Scionspire Consulting Services (India) Private Limited for setting up a new Unit :-**



The list of materials has been certified by a Chartered Engineer. The request was examined by the Unit Approval Committee. After deliberations, the Committee approved the procurement of the materials in terms of the provisions contained in Rule 12(2) of SEZ Rules, 2006.

**5.11 Request from M/s. Cheyyar SEZ Developers Private Limited, Bargur for procurement of materials:-**

M/s. **5.13 Request from M/s. Perungudi Real Estates Private Limited, Developer for procurement of materials:-**



**5.15 Allotment of space at Food Court by TIDEL Park, ELCOT-SEZ, Coimbatore:-**

The proposal of M/s. TIDEL Park Coimbatore Limited, Co-Developer of ELCOT-SEZ, Coimbatore for leasing out 812 sqft of space to M/s. Home Chef for running a restaurant in the Food Court for the benefit of employees working in the SEZ was deferred as no representative was present to explain the proposal to the Committee.





**5.16 Request of M/s. Wavicle Data Solutions for acquiring additional space:-**

The request for approval for acquiring additional space to the extent of 22 seats in Development Centre 27(DC-27) in ELCOT-SEZ, Coimbatore by M/s. Wavicle Data Solutions, a Unit in the SEZ was examined by the Unit Approval Committee. After deliberations, the Committee approved the acquiring of additional space by M/s. Wavicle Data Solutions, in view of the revised projections given by the Unit.

**5.17 Request for allotment of space by M/s. TRIL Info Park:-**



Mano Foods for setting up a Snack Bar for the benefit of employees working in the SEZ. The request of the Developer was examined by the Unit Approval Committee. After deliberations, the Committee approved the request of the Co-Developer for allotment of 375 sqft to M/s. Mano Foods for setting up a Snack Bar in terms of Instruction No.50 dated 15<sup>th</sup> March 2010 issued by Department of Commerce subject to the condition that no duty free material shall be allowed for setting up and operation of this facility.

**5.18 Request from M/s. DLF Assets Private Limited, Co-Developer, DLF IT/ITES SEZ for inclusion of additional service, viz., Real Estate Services in the list of authorised services:-**

M/s. DLF Assets Private Limited, Co-Developer of DLF IT/ITES SEZ, have requested for inclusion of "Real Estate Services" as an additional service apart from the default list of authorised services for availing the benefit of exemption of IGST. The Co-Developer has stated that the said service is required for identifying the new Unit to provide office space by the service provider on fee/commission basis/contract basis. The proposal of the Co-Developer for inclusion of Real Estate Services as additional service in the default list of authorised services was examined by the Unit Approval Committee. After deliberations, the Committee approved the request of the Unit for inclusion of Real Estate Service as additional service for availing IGST exemption.

**5.19 Request from M/s. DLF Assets Private Limited for procurement of materials:-**

M/s. DLF Assets Private Limited, Co-Developer of DLF Info City Chennai Limited, Ramapuram, Chennai have submitted for approval of Unit Approval Committee, a list of materials for an estimated value of ₹ 577.65 lakh (all Indigenous materials) with a duty forgone value of ₹ 103.97 lakh for construction of Office space (warm shell) in the SEZ. The list of materials has been certified by a Chartered Engineer. The request was examined by the Unit Approval Committee. After deliberations, the Committee approved the procurement of the materials in terms of the provisions contained in Rule 12(2) of SEZ Rules, 2006.



**5.20 Request of M/s. DLF Assets Private Limited for allotment of space to install ATMs:-**

M/s. DLF Assets Private Limited, Co-Developer of DLF Info City Chennai Limited, Ramapuram, Chennai have requested approval for allotment of space measuring 25 sqft each in Blocks 8 & 10 for installation of 2 ATMs by M/s. HDFC Bank Limited for the benefit of the employees working in the SEZ. The proposal of the Co-Developer was examined by the Unit Approval Committee. After deliberations, the Committee approved the request of the Co-Developer for installation of 2 ATMs in terms of Instruction No.50 dated 15<sup>th</sup> March 2010 issued by Department of Commerce subject to the condition that no duty free material shall be allowed for setting up and operation of this facility.

**5.21 Change of name of the implementing agency:-**

M/s. SQS India BFSI Limited, a Unit in MEPZ-SEZ was issued LOA on 11.12.2007 for setting up their Unit in MEPZ-SEZ.

Now, they have requested for change in the name of the implementing agency from M/s. SQS India BFSI limited to M/s. Expleo Solutions Limited. The Unit has furnished the requisite documents in this regard.

The proposal of the Unit was examined by the Unit Approval Committee. After deliberations, the Committee approved the request of the Unit for change in the name of the implementing agency from M/s. SQS India BFSI Limited to M/s. Expleo Solutions Limited in terms of the provisions contained in Rule 19(2) of SEZ Rules, 2006.


**5.22 Request for Broad-banding by M/s. Rishaba Industries, Chennai:-**

M/s. Rishaba Industries, Chennai was granted LOA on 06.09.2018 to set up an Unit in M/s. New Chennai Township SEZ for Light Engineering SEZ for manufacture and export of "Toys".

Further, the Unit was approved for Broad-banding of the following items during the UAC meeting held in 28.11.2018:-

- a) Tableware, Kitchenware, Other Household articles and toilet articles of Plastic (HS Code:39240000)
- b) Vacuum Flasks complete with cases, parts thereof other than glass inners (HS Code:96170000)
- c) Plastic Water bottle (HS Code:39261010).



While the Committee noted that the cumulative NFEE of the units was positive, Mrs. Usha Ramesh, Assistant was asked to ascertain the reasons for the shortfall in achievement of export, and employment projections from M/s. Seinsa Autofren India Private Limited, M/s. SFP Sons (India) Private Limited and M/s. Venture Power Systems India Private Limited. The Representative of M/s. Avalon Technologies Limited informed that due to reduction in order from their US customer, there was shortfall in achievement of the projections given for in respect of Unit-I and they would make up the shortfall in the years to come. As regards their Unit-II, he informed that due to high volume of sales in DTA, there was a shortfall in achievement of NFEE. The Representative of M/s. Manav Packaging Private Limited informed that due to import of capital goods during 2015-16 and 2016-17, there was decline in achievement of NFEE which they would make up in the coming years. The Representative of M/s. Urjita Electronics Private Limited informed that due to inclusion of the value of goods in the imported goods which they have received free of cost from their customers, there was shortfall in achievement of NFEE. The Representative of M/s. Vijay Garments informed that due to their high domestic sales, there was shortfall in achievement of NFEE which they have assured to make up in the years to come.

**5.25 Monitoring the performance of 15 units in DLF Info City Chennai SEZ:**

While the Committee noted that the cumulative NFEE of the units was positive, the Representative of M/s. Accel Frontline Limited informed that due to reduction in orders from their US clients, they could not achieve the projections given by them. He has assured to make up the shortfall in the years to come.

The Representative of M/s. Cognizant Technology Solutions India Private Limited (Unit-II) informed that since there was scaling down of operations by their customer, viz., M/s. Walmart, they could not achieve the projections given by them. However, he has assured of improved performance in the coming years.

The Representative of M/s. L & T Technology Services Limited attributed the overall global recession for their shortfall. He has assured to improve their performance in the years to come and make up the shortfall. M/s. Societe General Global Solution Centre Private Limited informed that since there was dip in receipt of orders, they could not achieve the projections in their second year of operations. However, he has assured with improvement in the business, they would make up the shortfall in the remaining period.

While the Committee noted that the cumulative NFEE of the units was positive, Mrs. Uma Raghunathan, ADC was asked to ascertain the reasons for the shortfall in achievement of projections given for exports, NFEE and employment from M/s. HCL Technologies Limited in respect of their Units IX and I.

**5.27 Monitoring the performance of 2 units in ELCOT-SEZ, Ilandhaikulam**
