# **Responsibility Summary:**

MEPZ SEZ is located at Tambaram in a close proximity of 9 km from Chennai International Airport and about 30 km from the Chennai Sea Port. - Develop detailed implementation plans for process improvements, outlining timelines, resource allocation, and training requirements.
