(4)	M/s. V.V. MINERAL	The Developer of the SEZ was issued LOA No. F.1/21/2009-SEZ dated 05.12.2012 for setting up an SEZ at Tirunelveli District, Tamil Nadu. The SEZ was notified on 16.12.2013. Extension of LOA was granted up to 04.12.2015. The request of the Developer for further extension of the validity of the LOA was not considered by this office, due to ban on mining imposed by the Government of Tamil Nadu . The validity of the LOA issued to the Developer lapsed on 05.12.2015.
(5)	M/s. Vedanta Ltd. (formerly M/s Sterlite Industries (India) Ltd.	The Developer of the SEZ was issued LOA No. F-1/31/2009-SEZ dated 02.02.2012 for setting up an SEZ at Tuticorin, Tamil Nadu. The SEZ was notified on 03.05.2013. The Developer has approached this office for De-notification of the SEZ. NOC for Exit has been issued by this office on 16.03.2018. The Developer is yet to complete the required formalities for Final Exit of the SEZ.
