1	Is it correct that the Development Commissioner is the Conciliation Officer in respect of any Disputes raising relating to the Workmen working in Special Economic Zone?	<p>In terms of G.O. Ms. 58 dated 26.3.2015 issued by Labour &amp; Employment Department, Government of Tamilnadu, the Development Commissioner/Joint Development Commissioner were delegated the powers of Conciliation Officer in respect of Industrial disputes in SEZs.</p> <p>In terms of G.O.Ms.89 dated 26.07.2018 issued by Labour &amp; Employment Department, Government of Tamil Nadu, Development Commissioner of SEZs was delegated the powers of Conciliation Officer in respect of Special Economic Zones concerned.</p>
2	Whether, The Development Commissioner has the Power to delegate his Power of Conciliation in respect of Workmen in Special Economic Zone to The Assistant Commissioner of Labour working under Labour Department?	In terms of sub section (6) of Section 12 of the SEZ Act, 2005, the Development Commissioner may delegate any or all of his powers to any of the officers employed under him. As the Assistant Commissioner of Labour working in Labour Department is not employed under Development Commissioner, MEPZ, the powers of Development Commissioner as conciliation officers was not delegated to

		Assistant Commissioner, Labour working Labour Department.
3	During the Period from 2012 to 2016. Whether the Development Commissioner has delegated the Power of Conciliation to the Assistant Commissioner of Labour, Coimbatore.	No, the Development Commissioner, MEPZ did not delegate the power of conciliation granted to him to the Assistant Commissioner of Labour, Coimbatore, during the period 2011-2016.
