ORDER OF THE FIRST APPELLATE AUTHORITY

An application dated 05.07.2021 under the RTI Act 2005 seeking certain information was received by CPIO, Office of Development Commissioner, MEPZ SEZ, Chennai from Shri S.Ravi Sangar, Resident of No.23, Sadasivan Nagar Extn-1, Madambakkam, Guduvancherry, PIN 603202, hereinafter referred to as the "Appellant".

2. The CPIO vide letter No.RTI/473/2021-22 dated 03.08.2021 had sent a reply to the Appellant furnishing the information sought by the Appellant. However, not satisfied with the reply given by the CPIO, the Appellant has now filed a First Appeal before me under Section 19 (1) of the RTI Act, 2005, through vide letter dated 09.08.2021.

3. I have gone through the contents of the Appeal in detail. The information sought by the Appellant from the CPIO, the information provided by the CPIO, the contention of the Appellant in the appeal and my decision in the capacity of First Appellate Authority for the point raised by the Appellant in his Appeal, is detailed below:

1	Provide the copies of CRs for the year 2013-14 & 2014-15.	In this regard, please refer the Central Information Commission decision vide No. CIC/AD/A/2013/001326-SA, dated 25.06.2014 that:- 1. "No Scope of repeating under RTI Act. 2. Citizen has no Right to Repeat 3. Repetition shall be grounds of refusal. 4. Appeals can be rejected." It is noted that, the appellant has already received response on the same subject vide letter dated 16/06/2020, 30/07/2020, 14/08/2020 and 03/08/2021.


