The Application with Original documents (importer copies of BEs) was sent by Speed Post on 14.09.2016 from Mylapore HPO vide Receipt No ET1281409151N addressed to Asst Development Commissioner MEPZ Special Economic Zone Tambaram.This must have been delivered on 15.09.2016 or latest by 16.09.2016 and entered into inward mail register or any such register being maintained in the office for receipt of such Letters /Documents etc being received By Post and courier service. 2. As per the Public Records Act 1993 and Public Records Rules 1997, all Public Authorities are required to maintain records for the last 10 years. RELIEF SOUGHT I request Appellate Authority to direct CPIO to make all efforts to trace the Application and Original documents and provide me the required information Or Alternatively issue a Certificate stating that the Application under above-mentioned Speed

Post Receipt No ET128140915IN booked on 14.09.2016 at Mylapore HPO was received on date (to be ascertained with reference to the inward mail register being maintained in the Office of Zonal Development Commissioner Tambaram) even though the original documents themselves may not be traceable immediately.
