







The One Hundred and Seventeenth (117th) meeting of the Board of Approval (BoA) for Special Economic Zones (SEZs) was held on 17th November, 2023 under the chairmanship of Shri Sunil Barthwal, Secretary, Department of Commerce at Vanijya Bhawan, New Delhi through hybrid mode. 117.1: Ratification of the minutes of the 116th meeting of the Board of Approval held on 5th September, 2023.

The Board ratified the minutes of the 116th meeting of the BoA for SEZs held on 5th September, 2023.

117.2: Request for extension of validity of formal approval of Developer (1 proposal)

117.2(i) Request of M/s. Cyber Corporation Manipur Limited (formerly M/s. Manipur IT SEZ Project Development Company) for further extension of the validity period of formal approval, granted for setting up of Manipur IT SEZ at Mantripukhri, Imphal, Manipur, beyond 31.10.2023.
