16.2 Request of M/s. Salcomp Manufacturing India Private Limited for amendment in the name of the item approved for manufacture and ITC HS Code

M/s. Salcomp Manufacturing India Private Limited, a Unit in Nokia Telecom SEZ was issued LOA No.08/02/2006/Nokia SEZ dated 12.06.2006 for manufacture and export of 'Power Supplies, Electronic goods mainly Chargers for Mobile phones and Electronic hand held devices and Telecommunication Equipments and other related accessories'.

Further, the Unit was given permission to manufacture the following items under broad-banding on 29.08.2019:

Now, the Unit has informed that the Item No.1 with ITC HS Code 8517 6990 – Other – Communication Gateways and Controllers are manufacture for the customer Enphase and shipped to USA. Whereas the customer call the item as 'Enphase Enpower Smart Switch Controller' which performs the same function as Gateways & Controllers and the customer declares this product under ITC (HS) Code 9032 8990 and hence requested for amending the Item No.1.

The proposal of the Unit for amending the Item No.1 to Enphase Enpower Smart Switch Controller with ITC HS Code 9032 8990 was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of provisions contained in rule 19(2) of SEZ Rules, 2006.

16.3 Request of M/s. Sonkam Stones Private Limited for setting up a 100% EOU at Varichiyur, Madurai, Tamil Nadu

The proposal of M/s. Sonkam Stones Private Limited for setting up a new 100% EOU at Sy.No.132 & 140, Sivagangai Road, Varichiyur, Madurai, Tamil Nadu 620 020, for manufacture and export of 'Polished Granite Random Slabs, Cut to size Tiles, Sand Stones and Slates' – ITC HS Code 68029310 – Capacity 25,00,000 sq.ft. with a projected investment of ₹ 2,317 lakh and projected NFEE of ₹ 16,330 lakh over a period of 5 years with an employment generation for 100 persons was examined by the Unit Approval Committee.

16.7 Request of M/s. HTL Furniture India Private Limited for setting up a 100% EOU at Venbakkam Village, Panruti Post, Kanchipuram

The proposal of M/s. HTL Furniture India Private Limited for setting up a new 100% EOU at Building B400 and B600, Indospace Industrial Park, Oragadam Walajabad Road, No.165, Kunnavakkam Bus Stop, Venbakkam Village, Panrutti Post, Kanchipuram − 603 109, for manufacture and export of 'Sofas' with a projected investment of ₹ 9,420 lakh and projected NFEE of ₹ 2,47,301 lakh over a period of 5 years with an employment generation for 1,000 persons was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in terms of the provisions contained in Para 6.05(a) of Foreign Trade Policy 2015-2020 and para 6.01(b) (i) of Handbook of Procedures 2015-2020.

16.8 Request of cancellation of LOA issued to M/s. Memsys Technologies Private Limited, a Unit in ELCOT SEZ, Salem

The proposal of cancellation of LOA issued to M/s. Memsys Technologies Private Limited, a Unit in ELCOT-SEZ, Salem was deferred by the Committee for want of additional information.

16.9 Request of M/s. ATC Tires Private Limited, a Unit in SIPCOT SEZ, Gangaikondan, Tirunelveli district for undertaking repair activity and re-export

M/s. ATC Tires Limited, a Unit in SIPCOT SEZ, Gangaikondan in Tirunelveli district was issued LOA No.8/1/2008-SIPCOT dated 30.07.2008 for manufacture and export, Trading of 'new Pneumatic Tyres of Rubber, Tyre Flaps and Inner Tyres of Rubber'. The LOA is valid up to 30.11.2024.

The Unit has made a request for undertaking repair of tyres (ITC HSN Code 4011700, 40118000) under broad-banding. The Unit has stated that they have facilities for repair of tyres in the present set up. During the manufacturing process, deposition of mass of rubber could be uneven that arises due to nature of elasticity of rubber and that is capable of being rectified with specialised

equipment and that they do possess such equipment. The Unit has received an enquiry from M/s. Alliance Tyres, Israel for repair of tyres and they have entered into an agreement with them.

The Unit has stated that they propose to import new tyres into the Unit, repair the same and re-export the tyres back to M/s. Alliance Tyre for which they would be receiving repair charges. The Unit has submitted revised projections consequent to this additional activity.

The proposal of the Unit for undertaking repair of new tyres and re-export under broadbanding was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in terms of the provisions contained in rule 19(2) of SEZ Rules, 2006 subject to the condition that the scrap/wasted arising out of repair activity shall also be re-exported along with the repaired tyres without fail.

16.10 Request of M/s. ATC Tires Private Limited for sub-contracting into DTA and clearance of moulds into DTA without payment of duty

M/s. ATC Tires Private Limited, an SEZ Unit in SIPCOT SEZ, Gangaikondan vide their letter dated 23.10.2021 submitted a request to accord permission to sub-contract the manufacture of bladders of various sizes and specifications to M/s. Excell Rubber Private Limited, Sy.No.314 & 315, Ameenpur Road, Bachupally Mandal, Medchal District, Hyderbad.

The Unit has stated that they will supply the moulds to M/s. Excell Rubber Private Limited. The DTA supplier will use their own raw materials. The Unit wants to clear moulds to their DTA customer for undertaking part of manufacturing process and send the finished goods to the SEZ Unit for export. The moulds will be returned to the SEZ Unit after the completion of production within a period as mentioned in the agreement.

The proposal of the Unit for sub-contracting the part of production process in DTA and clearance of moulds to them without payment of duty was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in view of similar permission given by the UAC in its meeting held on 25.03.2015.

The proposal of M/s.
