The Unit Approval Committee confirmed and ratified the minutes of the UAC meeting held on 13.08.2021.

9.1 Request of M/s. Axiogen Bio Tech, Chennai for setting up a new SEZ Unit in SIPCOT Multi Sector SEZ, Sriperumbudur

The proposal of **M/s. Axiogen Bio Tech** for setting up a new SEZ Unit in SIPCOT Multi Sector SEZ, Sriperumbudur, Kancheepuram District for manufacture and export of **“Enzymes, Biopolymers and Bio stimulants”** {Total products – 15 products given in Form-F} (Authorised Operations) with a projected investment of ₹ 100 lakh and projected NFEE of ₹ 1,665 lakh over a period of 5 years with an employment generation for 55 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Rule 18(2) of SEZ Rules, 2006.

9.2 Request of M/s. Expleo Solutions Limited for setting up a new SEZ Unit in KGISL SEZ, Coimbatore

The proposal of **M/s. Expleo Solutions Limited** for setting up a new SEZ Unit in KGISL SEZ, Coimbatore for providing **“Technical Testing and Analysis Services”** (ITC HS/CPC Code – 998346/8676) (Authorised Operations) with a projected investment of ₹ 460 lakh and projected NFEE of ₹ 6,742 lakh

over a period of 5 years with an employment generation for 300 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Rule 18(2) of SEZ Rules, 2006. The Unit has mentioned that since they have a DTA Unit, they will claim SEIS benefits from the respective Regional Authority (DGFT) and not from MEPZ.

9.3 Request of M/s. Salcomp Manufacturing India Private Limited for inclusion of additional product for manufacturing and export under broadbanding

M/s. Salcomp Manufacturing India Private Limited, having an SEZ Unit in Nokia Telecom SEZ, Sriperumbudur was issued LOA No.08/02/2006/Nokia SEZ dated 12.06.2006 for manufacture and export of **“Power Supplies, Electronic goods mainly Chargers for Mobile Phones and Electronic hand held devices and Telecommunication Equipments and other related accessories”**. The LOA is valid up to 03.06.2022.

Now, the Unit has made a request for manufacturing of additional product of the following item under broad banding:



The Unit has submitted revised projections on inclusion of the above items.

The request of the Unit for manufacturing the above additional product under broadbanding was examined by the Unit Approval Committee. After deliberations, the Committee deferred the proposal for want of additional information.

9.4 Request from M/s. Infosys Limited, Co-Developer in Mahindra World City SEZ for IT for procurement of materials

M/s. Infosys Limited, Co-Developer of Mahindra World City SEZ for IT, Chengalpattu have submitted for approval of Unit Approval Committee, a list of indigenous materials for an estimated value of ₹ 124.71 lakh with a duty forgone value of ₹ 30.35 lakh and imported materials for a value of ₹ 7.89 lakh with a duty forgone value of ₹ 2.45 lakh for its authorised operations, viz., for Chiller Plant, Education and Research Block, Employee Care Centre, Facility Block, Landscaping, Multi-Level Vehicle Parking , Sewage Treatment Plant and Software Development Blocks in the SEZ. The list of materials has been certified by a Chartered Engineer. The request was examined by the Unit Approval Committee. After deliberations, the Committee approved the same in terms of provisions contained in Rule 12(2) of SEZ Rules, 2006.



9.5 Cancellation of LOA issued to M/s. G.A. Morgan Dynamics Private Limited in ELCOT-SEZ, Salem

M/s. G.A. Morgan Dynamics Private Limited was issued LOA No.8/14/2001-ELCOT-SEZ/Salem on 29.04.2021 for setting up their Unit in ELCOT-SEZ, Jagirammalayam, Salem for carrying out the Service activities.

The Unit has vide letter dated 26.07.2021 requested to cancel their LOA. The Company has stated due to Covid-19 2nd wave of pandemic and its present uncertain business situation, their management has decided to cancel the new investment. Hence, they have decided to surrender the LOA.

The Unit has stated that they have not carried out any business/transaction after allotment and not even occupied the allotted space so far. In this regard, they have submitted the following documents:-

Copy of in-principle space allotment cancellation letter from the Developer (ELCOT Limited) vide letter dated 06.08.2021

The Specified Officer, Customs has confirmed that the Unit has not availed any exemption of duty/tax and issued No Dues Certificate.


The proposal for cancellation of LOA of **M/s. G .A. Morgan Dynamics Private Limited** was examined by the Unit Approval Committee. After deliberations, the Committee decided that the LOA issued to the Unit may be cancelled in terms of the provisions contained in Section 16(1) of the SEZ Act, 2005.

9.6 Request of M/s. TCL Technology and Engineering, a SEZ Unit in SIPCOT SEZ, Ranipet for acquiring additional space

The proposal of **M/s. TCL Technology and Engineering**, a SEZ Unit in SIPCOT SEZ, Ranipet for acquiring additional land of 3.55 acres in Plot No.A-17 in the SEZ for storage space, was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in SEZ Rules, 2006.

9.7 Request from M/s. Infosys Limited, Sholingnallur for procurement of materials

M/s. Infosys Limited, Developer of the SEZ at Sholingnallur, has submitted for approval of Unit Approval Committee, a list of indigenous materials for an estimated value of ₹ 548.62 lakh with a duty forgone value of ₹ 98.76 lakh and imported materials for a value of ₹ 115.78 with a duty forgone value of ₹ 35.88 lakh for its authorised operations, viz., Cafeteria and Software Development Block in the SEZ. The list of materials has been certified by a Chartered Engineer. The request was examined by the Unit Approval Committee. After deliberations, the Committee approved the same in terms of provisions contained in Rule 12(2) of SEZ Rules, 2006.




9.8 Monitoring the performance of a Unit in Span Ventures SEZ, Coimbatore
