

The request of the Developer to include 'Real Estate Appraisal Services' as an eligible service to avail GST exemption on procurement of the said service was examined by the Unit Approval Committee. After deliberations, the Committee approved the request of the Developer.

14.18 Request of M/s. Merrill Technology Services India Private Limited for change in shareholding pattern and change of company name

M/s. Merrill Technology Services India Private Limited, having an SEZ Unit in ELCOT-SEZ, Tidel Park, Coimbatore vide LOA No.8/2/2011/ELCOT-CBE SEZ dated 2.08.2011 has submitted a request for approval of change in the shareholding pattern of the company and consequent change of name of their company to M/s. Toppan Merrill Technology Services Private Limited.

The Unit has also informed that they have added Mr. Joann Patricia Kern as an additional Director in their Company.

The information given by the Unit about the change in the shareholding pattern of the company and consequent change of name of their company to **M/s. Toppan Merrill Technology Services Private**Limited and addition of one more Director was taken on record by the Unit Approval Committee.

14.19 Request of M/s. Cameron Manufacturing India Private Limited for surrender of space

The request for approval for surrender of 146 seats in DC 29-34 at 4th Floor to Tidel Park, Co-Developer of ELCOT-SEZ, Coimbatore by **M/s. Cameron Manufacturing India Private Limited** was examined by the Unit Approval Committee. After deliberations, the Committee approved the request of the Unit for surrendering the space in view of the reasons stated by them.

14.20 Request from M/s. YCH Logistics (India) Private Limited for one time permission to export to other Countries based on Customer requirements

M/s. YCH Logistics (India) Private Limited, having an SEZ Unit in SIPCOT Hi-Tech SEZ, Sriperumbudur was issued LOA No.8/10/2007/SIPCOT SEZ dated 14.09.2007 with the authorised service activity of 'End to End Supply Chain Management Services and Warehousing'.

The Unit has submitted that they had imported certain materials on behalf of M/s. Dell Technologies (on IOR Model). As per the information from M/s. Dell Technologies, demand for these products has reduced and none of the customers require these imported materials any more. Hence, they have requested this office to accord one-time permission to export these goods to other countries. The Unit has also submitted the list of materials to be exported.

The request of the Unit was examined by the Unit Approval Committee. After deliberations, the Committee observed that since there is already a provision under Rule 34 of SEZ Rules, 2006 whereby an SEZ Unit can export the unutilised goods imported or procured from Domestic Tariff area, there is no requirement of giving a one time permission by the Unit Approval Committee to the Unit for exporting these goods. Accordingly, the Committee decided to advise the Unit to go by Rule 34 of the SEZ Rules 2006 for its export requirements.

14.21 Request of M/s. YCH Logistics (India) Private Limited for sale of goods to DTA Units, Bonded Warehouses, other SEZs and EOUs

M/s. YCH Logistics (India) Private Limited, having an SEZ Unit in SIPCOT Hi-Tech SEZ, Sriperumbudur was issued LOA No.8/10/2007/SIPCOT-SEZ dated 14.09. 2007 for Service activity 'End to End Supply Chain Management Services and Warehousing'.

M/s. YCH Logistics (India) private Limited have stated that they do not have permission to serve to any other units except those Units that operate in SIPCOT Hi-Tech SEZ, Sriperumbudur, SIPCOT Growth Centre SEZ, Oragadam and Nokia Telecom SEZ, Sriperumbudur. Since very few units are operating in these SEZs, they have not been able to utilise their full capacity so far. They have also stated that M/s. FIH (Foxconn) operating in the same SEZ as a Warehousing Unit have got permission to serve DTA Units also.

It is pertinent to mention here that M/s. YCH Logistics (India) Private Limited was denied permission by Department of Commerce to carry out DTA sale in the year 2010. However, later in the year 2017, Department of Commerce had changed its stand and allowed M/s. FIH India Developer Private Limited and M/s. Container Corporation of India Limited (both warehousing Units in SIPCOT Hi-Tech SEZ, Sriperumbudur) to carry out DTA sale on the ground that Instructions No.49, 60, 701, 76 & 80 are specific to FTWZ Units only and will not be applicable to Service Units carrying out Warehousing Operations in a sector specific SEZ. Accordingly, M/s. FIH India Developer Private Limited was allowed to set up a Warehousing Unit by the UAC and the Unit was allowed to clear goods in DTA. Though CONCOR was also allowed to carry on DTA sales by Department of Commerce vide letter No.F.1/6/2016-SEZ dated 20.11.2017, they have not started their operations yet and they are in the process of partial de-notification of the SEZ. The Committee also noted that warehousing Units in MEPZ, Tambaram, have also been clearing goods in DTA.

In the above background, the request of the Unit to clear goods to DTA, Bonded Warehouse, other SEZs and EOUs was examined by the Unit Approval Committee. After deliberations, the Committee approved the request of the Unit in view of the fact that two Units in the same SEZ have already been allowed to clear goods to DTA based on Letters dated 20.11.2017 and 21.12.2017 of the Department of Commerce and that it is necessary to have parity among the Units in terms of the permitted activities.

14.22 Request from M/s. Integrity RCM Services Private Limited for acquiring additional space

The request for approval for acquiring additional space of 26,713 Sq.ft in Block 2, Part of 3rd Floor in DLF Info City Chennai Limited SEZ, by M/s. Integrity RCM Services Private Limited was examined by the Unit Approval Committee. After deliberations, the Committee approved the acquiring of additional space by M/s. Integrity RCM Services Private Limited in view of the revised projections submitted by them.

14.23 Request from M/s. Pegatron Technology India Private Limited for setting up their EOU

The proposal of M/s. Pegatron Technology Private Limited, for setting up a new Export Oriented Unit (EOU) at Plot 8, Phase-V, Mahindra World City, Chengalpattu for manufacture and export of 'Printed Circuit Board Assembly (PCBA) of Cellular Mobile Phones and Cellular Mobile Phones' with a projected investment of ₹1,21,245 lakh and projected NFEE of ₹6,73,957 lakh over a period of 5 years with an employment generation for 14,382 persons was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal in terms of the provisions contained in Para 6.05 (a) of Foreign Trade Policy 2015-20 and Para 6.01(b) (i) of Handbook of Procedures 2015-20.

14.24 <u>Cancellation of LOP issued to M/s. Premier Cotton Textiles</u>

M/s. Premier Cotton Textiles was issued LOP No.A/2010/039/EOU/TN dated 24.06.2011 for converting their DTA Unit into EOU for manufacture and export of Cotton Yarn. The Unit has not executed LUT and hence, Green Card was not issued to the Unit. The validity of the LOP issued to the Unit had expired on 23.06.2014. The Unit vide their letter dated 18.02.2015 addressed to the Dy. Commissioner of Central Excise, Pollachi with a copy marked to this office informed that they have not executed Legal Undertaking or B17 Bond for implementing the EOU project. As per condition (vi) of the LOP, their LOP got expired on 23.06.2014. They have not applied for extension of the validity of LOP.

This office vide letter dated 05.01.2006 requested Central Excise, Coimbatore to confirm the non-execution of B-17 bond for cancelling the LOP of the Unit. No reply has been received from Central Excise, Coimbatore so far. The Unit while applying for converting their DTA Unit into EOU informed that they have pending Export Obligation against 2 EPCG Licences i.e. 3230013580 dated 29.07.2009 and 3230014604 dated 22.03.2010. Now, they have submitted copies of discharge of EPCG Authorisation for both Licenses issued by JDGFT, Coimbatore vide F.No.32/21/21/00347/AM10 dated 06.02.2015 and F.No.32/21/21/01368/AM10 dated 06.02.2015.

Now, the Unit vide their letter dated 24.11.2020 have stated that they have not applied for extension of validity of LOP and not executed LUT or B-17 bond for implementation of EOU project and hence requested this office to take these facts on record and close the issue at the earliest. The request of the Unit for cancellation of LOP was examined by the Unit Approval Committee. After deliberations, the Committee decided to cancel the LOP issued to the Unit under intimation to the Customs in view of the fact that the Unit neither executed LUT nor B-17 bond and their LOP got expired on 23.06.2014.

The meeting concluded with a Vote of thanks with the information that the next UAC meeting will be held on 30th December 2020.
