After deliberations, the Committee approved the same in terms of provisions contained in Rule 19(2) of SEZ Rules subject to the condition that the Unit shall re-export the Laptops and Desktops after repair including Scraps and nothing to be cleared in DTA.

The meeting concluded with a vote of thanks.
