Since the Developer has a closing stock of 1,06,714 KL of Diesel as on 31st December 2023 and taking into the average monthly consumption of Diesel during 2023-24 as 9,786 KL during January 2023 to December 2023, the Developer may require another 29,359 KL of diesel for the remaining 3 months. In view of the fact that the Developer has already in possession of 1,06,714 KL in hand as on 1st January 2024 which can take care of their requirements for another 9 months, the Developer may be asked to approach the UAC, as and when they consume 50% of the stock in the hand.
