The Unit is involved in the Software Development, viz., Designing, Development of Proto-typing and validation of products for worldwide operations for the Aerospace, Automation and Control Solutions and specially materials of Honeywell. They develop the design, procure components on payment of applicable duties and prototype them using in house expertise and/or external vendors/sub assembly houses, does the necessary product qualifications and supply master pieces/Samples with no commercial value to M/s/Honeywell locations worldwide.

They develop application software and embedded software. For testing and validating embedded software, they need representative hardware platform. The hardware platform required only for testing alone developed as prototype and used for evaluating and validating purpose. Prototype and testing is very much essential in HTSL for development of software.

They are getting lots of requests from Aerospace Honeywell Global Units asking them to manufacture hardware units as commercial shipments. Currently they require manufacturing trade benches and solenoid valves and switching assembly for Aerospace units. The products which are required to be traded manufactured are electronics and mechanical goods. Honeywell intend to carry out the manufacturing activity in their SEZ. 


