After getting down from the company bus, the employees are required to walk more than 2 km to enter into their DTA/SEZ facility.

They have requested this office for permission to use the turnstile/flap gates on existing two sides of the SEZ metal mesh fence to ease the movement of their women employees, who wanted to use the crèche facility also.

They have stated that they will install additional CCTV camera at both the gates to monitor the movement of employees and will provide the footage at any point of time, as and when required.

The Authorised Officer has recommended for issue of approval sought by the Co-Developer since the proposal involves only movement of employees/workmen between the SEZ and DTA Unit of the same company.

The request of the Co-Developer was examined by the Unit Approval Committee. After deliberations, the Committee approved the proposal of the Co-Developerfor a period of two years, subject to the condition that the Co-Developer shall not claim any duty benefits for setting up the Turnstile Gates and CCTV cameras.
