10.01 Request of M/s. Green Nature Company for setting up a SEZ Unit in SIPCOT SEZ, Bargur.

The proposal of M/s. Green Nature Company for setting up their SEZ Unit in SIPCOT SEZ, Bargur, for Manufacture of `Corn-starch Cups - Others' with a projected investment of ₹ 4.84 crore and projected NFEE of ₹ 6.66 crore over a period of 5 years with an employment generation of 20 persons was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules, 2006.

M/s. Coral Engineering works India Pvt. Ltd. a unit in SIPCOT SEZ, Perundurai was occupying 2.02 hectares at Plot No.M-6 in the SEZ. 10.12 Request of M/s. Cotiviti India Pvt Ltd, an SEZ unit in KGISL SEZ, Coimbatore, for surrender of space

M/s. Cotiviti India Pvt Ltd., a SEZ Unit in India Land Tech Park, KGISL SEZ, Coimbatore, has requested for surrender of 2,440.36 Sq.mtrs of built up space in 7th Floor, Tower A to the Developer. The reason for surrender of space stated by the Unit is due to



their business requirement and for better management of resources. There is no change in projections on account of surrender of space.

10.14 Request of M/s. BM Continental Granites and Minerals Limited (formerly known as M/s. The Continental Enterprises), a unit in SIPCOT SEZ, Bargur, for cancellation of LoA.

M/s. BM Continental Granites and Minerals Limited (formerly known as M/s. The Continental Enterprises) was issued LoA for setting up their Unit in SIPCOT SEZ, Bargur on 25.02.2011. The Unit has neither executed LUT nor commenced their production. The Unit has made a request to this office for cancellation of the LoA issued to them and stated that their project could not be implemented as planned due to various unforeseen challenges. No Due Certificate has been issued by the Specified Officer.

The request of M/s. BM Continental Granites and Minerals Limited_for cancellation of LoA issued to them was examined by the Unit Approval Committee. After deliberations, the Committee approved the same in terms of provisions contained in Section 16(1) of SEZ Act, 2005.

10.15 Request of M/s. SES Global Technology Services India Private Limited for setting up a SEZ Unit in DLF Info City, Chennai.

The proposal of M/s. SES Global Technology Services India Private Limited for setting up their SEZ Unit in DLF Info City Chennai Limited SEZ, Chennai for 'Data processing services in relation to human resource, finance and other support services, Information Technology support services including software consulting and Back-office operations, computer software



services, call centre services, business services, professional services' with a projected investment of ₹ 11.95 crore and projected NFEE of ₹ 193.75 crore over a period of 5 years with an employment generation of 300 persons was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules, 2006.

10.16 Request of M/s. Barclays Global Services Centre Private Limited, a SEZ Unit in DLF Info City Chennai Ltd., for acquiring additional space

M/s. Barclays Global Services Centre Private Limited, an SEZ Unit in DLF info City Chennai Limited, has requested this office for approval of acquiring an additional space of 1,34,241 sq. ft. (Entire 2nd Floor of Block 9A & 9B) in the SEZ. The unit has stated that the total area after acquisition would be 5,09,882 Sq. ft. The unit has stated that there is no change in projections and employment on account of additional space.
