The Unit commenced the production activities with effect from 28.05.2021.</p> <p>A Showcause Notice was issued to M/s. VJP Shipping India Private Limited on 08.08.2024 for having persistently contravened the provisions of SEZ Act, 2005. The Development Commissioner adjudicated the Notice and issued Order dated 11.11.2024, imposing a penalty of ₹ 10,000 under Section 11(2) read with Section 13 of the Foreign Trade (D & R) Act, 1992 and recommended for</p>	<p>The proposal for cancellation of LoA of the Unit was examined by the Unit Approval Committee. ii. M/s. VJP Shipping India Private Limited is not permitted to file any documents (Eg. Z type Bills of entry, Bill of Export etc.) for inward movement of goods for the purpose of warehousing.

iii. M/s. VJP Shipping India Private Limited is permitted clearance of goods (already warehoused) belonging to their clients by following the prescribed procedure under law and the Authorised Officer shall process any Bill of Entry / Shipping Bill as the case may be as per law except in case of (iv) mentioned below.

iv. M/s. VJP Shipping India Private Limited is not permitted for clearance of any goods that have either been taken up for investigation by DRI/ SIIB (Customs House, Chennai) or seized under Customs law, Customs Act, or referred to jurisdictional Customs authorities for any investigation / verification. Such goods shall be handed over to the Developer under proper acknowledgement after taking approval from the Investigation Agencies/ Jurisdictional Customs authorities.
