The report regarding /s. DBI Digitalization and Implementation Limited, ELCOT SEZ, Vadapalanj has already been submitted to the SO/DC Customs in e-office last week itself. It is submitted that the Unit remains incommunicado for a very long time and the correspondences sent to them has been returned undelivered. They could not be contacted over phone through the last known phone nos and nobody is there to answer them. As such, the developer have sought to cancel their LOA. It has been confirmed from NSDL Karthi that there are no dues pending from them. However, it is submitted that the unit has filed their first SOFTEX (Request ID 142000102425, Softex No.S20S00452366) for single invoice No. AH001 dated: 31.03.2020 on 27.04.2020 for the period from 26.03.2020 to 31.03.2020 for export value USD 3500. The same was verified and certified by the AO. Further the unit has filed SOFTEX (Request ID 142000171622, Softex No. S20S00724806) for single invoice No.2001321 dated: 01.07.2020 on 08.07.2020 for the period from 01.07.2020 to 07.07.2020 for export value **EUR 40004000 (Approx. Rs.360 Crores)**.

2. Shri. Pravin Kumar J, Director, M/s.DBI Digitalisation And Implementation, Elcot IT/ITeS SEZ, Vadapalanji, Madurai vie his email dated 21.04.2021 has inter-alia stated that they had filed SOFTEX during lockdown period due to lack of guidance instead of receivables; that they filed for the total amount for the tenure of 4 years; that their client also had huge impact of covid pandemic; that client will either update or put on hold the project. Finally, they have requested to take a decision on the SOFTEX which is still not receivable to them.
3. Apart from the above said two SOFTEX, the unit has not filed even a single SOFTEX from August 2020 to till date. Further it appears that the unit have not received any advance till date and not made any export till date from April 2020. From the above it appears that the SOFTEX, in question, is liable for rejection in SEZ online. As per Rule 74 of the SEZ Rules, 2006, with the approval of the Development Commissioner, a Unit may exit subject the payment of applicable duties on the imported or indigenous Capital Goods, raw materials, components, consumables, spares and finished goods in stock. As they have not procured any goods with tax benefits, it is submitted that the Unit has no tax dues and their exit from SEZ may be considered as there is no response from them either to the letters from the Developer or from the Office of the Authorised Officer, SEZ, Vadapazhanji, Madurai.

Hence the LOA No.8/4/2020-ELCOT –MDU/VADAPAZHANJI dated 19.3.2020 issued from the Ministry of Commerce & Industry may be cancelled as the Unit is remaining in the non-operational list for a sufficiently longer period of time.

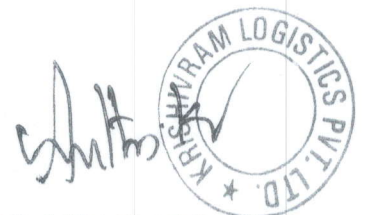

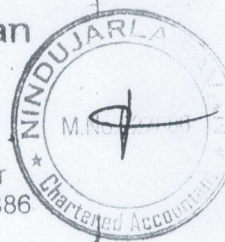

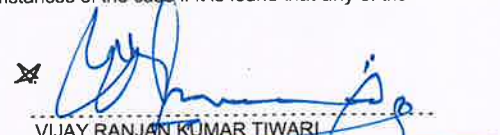
