The post to be filled through absorption shall be subject to the availability of provisions in the Recruitment Rules of the post and it shall be Ministry of Commerce & Industry for making any appointment.
	The employees working in public sector under taking with pay scale IDA of Rs, 12100 - 2300 and current Basic pay Rs, 19830 and DA Rs, 46,938 Gross salary Rs, 75, 195 which post are eligible to absorption as per your recruitment rule.	The information sought at Sl. No. 2& 3 is in the nature of a hypothetical query seeking clarification/opinion regarding the eligibility of an employee for absorption in the organization based on certain assumed service particulars. Under Section 2(f) of the Right to Information Act, 2005, "information" means material available in any form and held by or under the control of the public authority. The RTI Act does not cast an obligation to create information, draw inferences, interpret rules, or provide opinions/advice in response to hypothetical situations.
