का.आ.1507(अ).—यतः मै. ईटीए टैक्नोपार्क प्रा. लि., जो तमिलनाडु राज्य का एक पूर्णतः निजी संगठन है, ने तमिलनाडु राज्य के ओलड महावलिपुरम रोड, नवल्लूर गांव, चेंगलपेट तालुक, जिला कांचीपुरम में सूचना प्रौद्योगिकी एवं सूचना प्रौद्योगिकी समर्थित सेवाओं के लिए एक क्षेत्र विशिष्ट विशेष आर्थिक जोन की स्थापना हेतु विशेष आर्थिक जोन अधिनियम, 2005 (2005 का 28), जिसे एतदपश्चात् अधिनियम कहा गया है, की धारा 3 के अंतर्गत प्रस्ताव किया है;

और यतः, केन्द्र सरकार इस बात से संतुष्ट है कि अधिनियम की धारा 3 की उप-धारा (8) के अंतर्गत अपेक्षाओं तथा अन्य संबंधित अभ्याओं को पूरा कर लिया गया है और उसने उक्त नवल्लूर गांव, चेंगलपेट तालुक, जिला-कांचीपुरम में सूचना प्रौद्योगिकी एवं सूचना प्रौद्योगिकी समर्थित सेवाओं के लिए एक क्षेत्र विशिष्ट विशेष आर्थिक जोन के विकास एवं प्रचालन हेतु अधिनियम की धारा 3 की उप-धारा (10) के अंतर्गत दिनांक 19 जून, 2007 को अनुमोदन पत्र प्रदान कर दिया है;

अतः अब अधिनियम की धारा 4 की उप-धारा (1) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और विशेष आर्थिक जोन नियम, 2006 के नियम 8 के अनुसरण में केन्द्र सरकार एतद्वारा तमिलनाडु राज्य में ओलड महावलिपुरम रोड, नवल्लूर गांव, चेंगलपेट तालुक, जिला कांचीपुरम में निम्नलिखित क्षेत्र को एक विशेष आर्थिक जोन के रूप में अधिसूचित करती है जिसमें निम्नलिखित तालिका में उल्लिखित सर्वेक्षण संख्याएं और क्षेत्र शामिल हैं, अर्थात् :—
