NOTIFICATION

S.O. 581- (E).- Whereas M/s Lotus Footwear Enterprises Limited, a company incorporated in British virgin Islands, being part of the Growth-Link Group of companies, had proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), hereinafter referred to as the Act, to set up a sector specific Special Economic Zone for footwear, at Mathur, Mangal Villages, District Thiruvannamalai, in the State of Tamil Nadu;

And whereas the Central Government is satisfied that requirements under sub-section (8) of section 3 of the Act, and other related requirements are fulfilled and it has granted letter of approval to the said company under sub-section (10) of section 3 of the Act for development and operation of the sector specific Special Economic Zone for footwear at Mathur, Mangal Villages, District Thiruvannamalai, in the State of Tamil Nadu on 3rd November, 2006;

And whereas a wholly owned subsidiary of Lotus Footwear Enterprises Limited was incorporated in India by the name of "Cheyyar SEZ Developers Private Limited" on 13th November, 2006 for the development of said Special Economic Zone;

And whereas the Central Government has granted the approval for the change of the name of the developer to set up sector specific Special Economic Zone for footwear from "Lotus Footwear Enterprises Limited" to "Cheyyar SEZ Developer Private Limited" on 14th December, 2006 and amended the approval granted on 3rd November, 2006 to that extent;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Act and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at Mathur, Mangal Villages, District Thiruvannamalai, in the State of Tamil Nadu comprising of the Survey numbers and the area given in the Table below, as a Special Economic Zone, namely :-
